 - A. TAP Updates –

Resolution Tentatively Approving the Plans, Specifications, Form of Contract, and Estimate of Total Cost for the 2014 High School Renovation Project and Setting the Time, Date, and Location for a Hearing Thereon and Further Authorizing the Advertisement for Competitive Bids on Said Woodside Project

The architects with Haila Architecture have completed the design and planning phases of the 2014 High School Renovation Project. The proposed plans for this project have been before Committees of the Board as well as this Board, most recently at the regular Board Meeting on December 9, 2013.

The Superintendent further recommends that the Board begin Advertising for Bids on this project on January 17th, 2014, with a submission date of February 20th, 2014. A public hearing will be held on these proposed plans, specifications, form of contract, and estimate of total cost on February 24th, 2014, at 6:00 p.m. in the Saydel District Office Boardroom.

RESOLUTION TENTATIVELY APPROVING THE PLANS, SPECIFICATIONS, FORM OF CONTRACT, AND ESTIMATE OF TOTAL COST FOR THE 2014 HIGH SCHOOL RENOVATION PROJECT AND SETTING THE TIME, DATE AND LOCATION FOR A HEARING THEREON AND FURTHER AUTHORIZING THE ADVERTISEMENT FOR COMPETITIVE BIDS ON SAID 2014 HIGH SCHOOL RENOVATION PROJECT

WHEREAS, it is deemed advisable and necessary by the Board to renovate the Saydel High School within the Saydel Community School District, and therefore, the Board has caused to be prepared and now has received a recommendation from the Administration for plans, specifications, form of contract, together with an estimate of total cost, which will be on file in the office of the Secretary for public inspection at the time of publication of the notice for public hearing for the 2014 High School Renovation Project, and said plans, specifications, form of contract, and estimate of total cost are deemed suitable for the construction and installation of said public improvements; and

WHEREAS, before said plans, specifications, form of contract, and estimate of total cost may be adopted, and contract for the 2014 High School Renovation Project be entered into, it is necessary to hold a public hearing and advertise for bids:

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS FOR THE SAYDEL COMMUNITY SCHOOL DISTRICT, IN THE COUNTY OF POLK, STATE OF IOWA:

Section 1. That it is hereby determined that it is necessary and advisable to renovate the Saydel High School within the Saydel Community School District, in the manner set forth in the plans, specifications, form of contract, and estimate of total cost above referred to, in accordance with the provisions as set out in the published Notice of Hearing and Advertisement for Bids as follows: [see attached Notice of Hearing and Advertisement for Bids to be Published in Newspaper]

Section 2. The Secretary is directed to publish the Notice of Hearing to reflect a public hearing to be held at 6:00 p.m. on the 24th day of February, 2014 in the Boardroom of the Saydel

Community School District. Said Notice to be published in the *Des Moines Register*, a legal newspaper, printed wholly in the English language, published in the County in which the work is to be done at least once weekly, and is a newspaper of general circulation in the District. The publication shall be at least four (4) days but not more than twenty (20) days prior to the date set for the public hearing.

Section 3. The Secretary is also directed to publish the Advertisement for Bids beginning on January 17, 2014, with bid submission date set for February 20, 2014. Said Advertisement for Bids to be published in the *Des Moines Register*, a legal newspaper, printed wholly in the English language, published in the County in which the work is to be done at least once weekly, and is a newspaper of general circulation in the District. The publication shall be at least four (4) days but not more than forty-five (45) days prior to the date set for receiving bids.
