- B. **Project Budget** Business Manager Ryan Eidahl provided a short preview of the proposed bid packages and contracts for the 2016 Cornell Elementary Addition & Outdoor Classroom from Estes Construction. The total project cost is estimated at \$3,170,231, and our budget was \$3,103,000. Ryan noted the bids came in competitively and shared the administration's recommendations to approve or reject as follows in the meeting.
- C. Contract Bid/Award Process Superintendent Mr. Douglas Wheeler reviewed the contract and big/award process. He said by breaking up the bid packages, it opened up the bidding to local companies. Mr. Wheeler provided Estes Construction with names of local businesses that have worked with Saydel previously. Then Estes was able to contact those businesses and encourage them to submit bids. Through that process, the Saydel community was able to see that it is the Board's desire to support local business. Mr. Wheeler said he has been pleased with the bidding/award process so far. Once the bid openings were complete, Estes Construction did the pre-award interviews. Sam Stagg and Art Baumgartner of HAILA Architecture, along with Scott Sheller, senior project manager at ESTES Construction, attended the meeting to share their input about the bids and interviews.
