- I. Call the Meeting to Order Meeting called to order by President Brian Bowman at 7:00 PM

II. Board Development

A. Financial Indicators

IASB would like school board members to be familiar with seven General Fund Key Financial Indicators. Ryan Eidahl, Business Manager, overviewed two of those seven factors. He explained Unspent Authorized Budget (UAB) Ratio and Annual Unspent Spending Authority. Ryan also shared a checklist Board members can use when auditing school bills.

III. Discussion / Action Items –

A. Curriculum, Instruction and Assessment – Grading and Feedback

Superintendent Mr. Douglas Wheeler began the presentation with a Know-Want to Know-Learned (K-W-L) strategy, asking the Board to reflect on what they know about Standards-Referenced Grading (SRG) and what they want to learn about SRG. Following the activity, Dr. Simone Alekno, Director of Curriculum, Instruction & Assessment, explained that SRG is a system of teaching, assessing, and providing feedback. Grading is based on end-of-year expectations or standards, and the feedback is based on a four-point scale. Dr. Alekno outlined the differences between traditional grading and SRG. She showed sample report cards of traditional and SRG-based grading. The Board watched a video by Dr. Douglas Reeves titled "Toxic Grading Practices" and reviewed a complete summary of these practices. Several testimonial videos were shared of sixth grade students talking about the benefits and their experiences with SRG. Then the Board graded a messy room using the traditional system followed by four-point scale grading of 1) Not Proficient 2) Partially Proficient 3) Proficient 4) Exemplary. Following discussion, Mr. Wheeler and Dr. Alekno outlined a working timeline for the implementation of SRG. The Board completed the K-W-L worksheet, reflecting on what they learned about SRG and what they still want to learn during future educational sessions.
