1. **Speed & Agility Training Program - Physiotherapy** – Motion to approve by Chad Vitiritto, seconded by Melissa Sassman. Motion carried 5/0. The goal of the training program is to educate athletes on correct body mechanics and to enhance performance through sport specific

movement. The program includes 18 sessions offered at various times from the end of May to the beginning of August. Total estimated cost is \$1,620 and will paid for from a donation from the Athletic Booster Club.

- 2. **Qualtrics** Motion to approve by Chad Vitiritto, seconded by Melissa Sassman. Motion carried 5/0. Qualtrics is a software program used to present and analyze data. It offers a simple dashboard that can be set up after data is uploaded. Qualtrics is commonly found in business and higher education and has recently begun to filter down into K-12. It offers a data analytics tool and a survey tool along with their data dashboard tool. Cost is \$7,000 per year with a one-time \$4,000 set charge, which also includes help through completion of setup for one project, which would be an at-risk dashboard.

4. Saydel High School Water Service Project

- a. Public Hearing on Plans, Specification, Form of Contract and Estimate of Total Cost of Construction At 6:16 PM, Board Vice President, Chairperson Pro Tem Jennifer Van Houten said it was the time and place for the public hearing on plans, specifications, form of contract and estimate of total cost of construction for the Saydel High School Water Service Project, published pursuant to the provisions of the Code of Iowa. She inquired whether there were any residents or taxpayers who would like to speak regarding the topic or if there were any written comments received prior to the meeting. Hearing none, at 6:17 PM, Board Vice President, Chairperson Pro Tem Van Houten declared the time for receiving objections to, or arguments in favor of the proposed project closed.
- b. **Recommendation for Award of Project Bids** Board Member Chad Vitiritto introduced the following Resolution entitled "Resolution Making Award of Construction Contract" and moved its adoption. Board Member Melissa Sassman seconded the motion to adopt. Motion carried 5/0. Vice President, Chairperson Pro Tem Jennifer Van Houten declared the Resolution adopted. There were five contractors that placed bids for the Saydel High School Water Service Project. The Board accepted the lowest responsive, responsible base bid from Valley Plumbing Co., Inc. in the amount of \$142,962.70.
